# THE CAJON VALLEY UNION SCHOOL DISTRICT'S ANNUAL AND FIVE –YEAR FEE REPORT FOR THE <u>2024/25</u> FISCAL YEAR

It is a requirement of Government Code Sections 66006 and 66001 that school districts provide certain financial information to the public each year.
