Subject: Lead Sampling of Drinking Water in California Schools

Dear Dr. Miyashiro:

Congratulations, all water samples collected at the schools listed below in the Cajon Valley Union School District have come back ND (Not Detected). Five samples were drawn from each school. As required by State regulations, the laboratory will report the results to the State Water Resources Control Board, Division of Drinking Water (DDW).

Per the DDW: All initial sample locations with a test result of less than or equal to 15 ppb (parts per billion) have lead levels less than the Action Level, the location is suitable for consumption, and no further testing is needed.

We have also provided a copy of the laboratory results as an attachment to this letter. Padre Dam Municipal Water District's Water Quality Specialist, Joe Guzzino, will review the results with James Beard for the following schools.

- Blossom Valley Elementary School
- Crest Elementary School
- Los Coches Creek Middle School
- Rios Elementary School

With the results being below the action level of 15 ppb, the State requires no further action from the School District or Padre Dam, and the Lead Testing in Schools will be considered completed and closed.
